# 6. Role & Responsibility of District institute of Education and Training :

Students of Govt. College Jukhala may avail the following facilities of the DIET, Bilaspur with the prior permission and intimation without any financial implication to the first party and second party.

- ii. Visit and exploration of science centre
- iii. Availing the facility of virtual laboratory of DIET
- iv. Free on hand training to students for preparing science models etc

### 7. Period of Agreement:

The parties to continue their partnership indefinitely, subject to ongoing review and mutual agreement to extend, adjustment or termination as desired by either party.

### 8. Termination:

This agreement will be terminated if any violation as well as any deviation from above mentioned term and conditions is noticed or reported at any stage by the first party (GC Jukhala) and second party (DIET).
