- ❖ Recognition and Accreditation (10/20): NAAC accreditation is below the highest level, and rankings from agencies like NIRF are missing. Efforts should be made to improve in these areas.

Opportunities:

* Collaboration with Industries and Research Institutions: Enhancing partnerships with educational and research institutions can open up opportunities for internships, placements, and research projects.

- Expansion of Student Support Services: Introduction of more add-on courses and competitive exam coaching can increase student success rates in national exams.
- Improved Faculty Development: Encouraging faculty to engage more in research, innovation, and conferences will enhance academic reputation and output.

Threats:

- Stagnation in Research Output: Limited faculty participation in research activities could hinder the institution's academic growth and its ability to stay competitive.
- Funding Constraints: Dependence on government and external funding for infrastructure upgrades and academic initiatives may limit long-term sustainability if not addressed proactively.
