
A meeting of Internal Complaints Committee was held on 15<sup>th</sup> July, 2024 at 2:40 pm in the Principal's office.


Minutes of the meeting held on 28<sup>th</sup> October, 2024 in Principal's office at 3:10 pm.

Minutes of the meeting held on 12<sup>th</sup> December, 2024 in Principal's office at 2:40 pm.



The meeting ended up with a vote of thanks to the chairperson.


